Happy New Year and Welcome 2020!



Introducing Virtual Reading Coaches

great add-on assignment - only 30 minutes a week

We're excited to introduce a new virtual opportunity for our volunteers to engage with students to improve their literacy skills.

Virtual Reading Coaches is an innovative, 1:1 tutoring program from United Way that matches a tutor with local classrooms for guided reading support.

Volunteers tutor students in reading through a safe and secure digital setting. Together, students and tutors read e-books using super simple screen sharing and audio.

Sessions can be conducted from any computer, tablet or smart phone.

If you think literacy is important for our children and you don't have a lot of time to visit classrooms, this might be perfect for you.

"The seniors that I assist just need a little help to remain independent in their homes, which is their goal," said volunteer Claire Porter, a retiree who gives about 10 hours per week to RSVP's Help on Call program. She assists 3 blind people with paperwork and two others with grocery shopping.

"I get a lot of satisfaction from knowing I've helped and made a positive difference in their lives," said Porter. "I've volunteered with most of these seniors for several years, so we've created a strong bond. Often times, they just need someone to talk to and listen to them."

UPDATE

Although Medicare's Annual Open Enrollment period ended on December 7, 2019, if you are enrolled in a Medicare Advantage Plan you can still make some changes until March 31, 2020. During the period from January 1 to March 31 you can leave a Medicare Advantage plan and switch back to Original Medicare and then purchase a Medicare Supplement and a Part D prescription plan. You can also switch from one Medicare Advantage plan to another.

Medicare recently published changes to premiums and deductibles for 2020. Starting January 1, 2020 most of us will be paying \$144.60 for the Part B premium. The income limit for the \$144.60 premium has gone up from \$85,000 pp/yr to \$87,000 pp/yr. The annual Part B deductible will be \$198 if not covered by your supplement plan. The maximum deductible for Part D prescription plans will be \$435.


